Fee Options:

Current Fiscal year: July 1, 2023 – June 30, 2024

Mid-year: Discounted rate for any time after January 1, 2024 – June 30, 2024 *with an obligation for full-year subscription for the following full fiscal year (July 1, 2024-June 30, 2025)**

Test Ordering & Development Process: A Multiple-Choice template is provided to the customer for their review. It will contain approximately 125 test questions to choose from. The customer chooses questions and notifies CODESP. CODESP creates the test from the questions chosen. The final test is returned to the customer by password protected email.

Interview Questions are available on a limited basis. Each interview template contains approximately 15 interview questions. Examples of subject areas provided in the interview templates: Instructional Aide; Special Education; Bilingual Spanish; Office Technician.

Terms of Service:

Afterschool-Head Start providers will have:

- The ability to order multiple-choice test and interview templates to review and select questions that will be used to develop final test content
- Multiple-choice tests and interview questions sent from CODESP through password-protected email to HR or other administrator contacts who have signed a CODESP Security Agreement
- The ability to administer the multiple-choice tests in secure proctored locations; a list of test site locations must be submitted with the CODESP Subscriber Agreement.
- This agreement does not include access to the secure areas of the CODESP website

PAYPAL PAYMENT OPTION: Customers have the option to pay with a credit card through PayPal. Payments through PayPal will be subject to an additional 3.5% service fee.

The final selection of test materials is the customer's responsibility.
