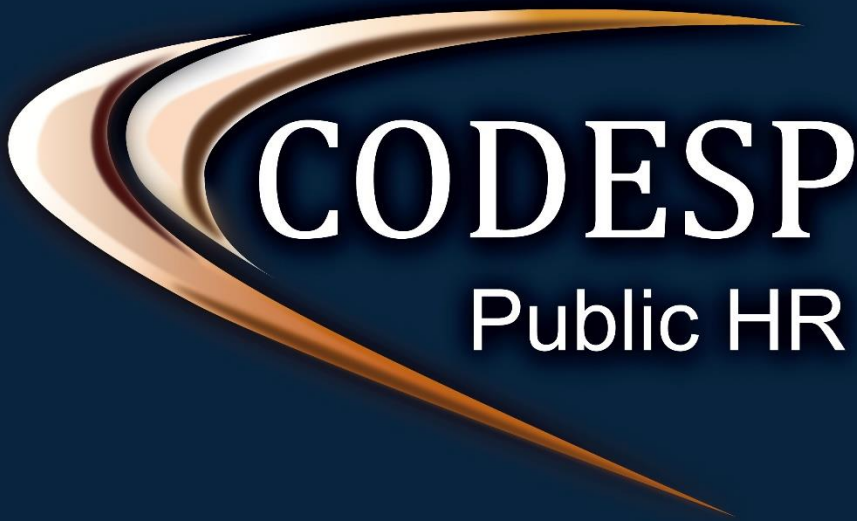

The new rate is \$17,202.84/year, which is \$1,964.76 more than last year. This new rate will require employees to pay \$167.73/month if the cap is not raised.</p> <p>RECOMMENDATION: Accept the new rates from ASCIP for benefits coverage from October 1, 2023 to September 30, 2024 and increase the employee benefit cap to \$17,202.84 for qualifying CODESP employees.</p>

10. Lease for Suite 325 Attachment 10a-b Motion: Second:	<p>Information: The lease for our current office is up September 1, 2023. Investor’s Trust has provided a lease at a cost of \$1,695 per month for Suite 325 for 2023-24 and \$1,815 per month for 2024-25. The cost per month for 2022-23 for Suite 400 was \$2,785.35 and would be increasing to \$3,054.90 for 2023-24. It has been determined that due to staff primarily working remotely at the current time, less actual office space is required. We have viewed Suite 325 and determine that it will be sufficient for our current needs and provide us with a cost savings.</p> <p>RECOMMENDATION: Authorize the Executive Director to execute the lease agreement with Investors Trust for Suite #325 at Seaview Plaza at a cost of \$1,695 per month for the period of September 1, 2023 to August 31, 2024 and \$1,815 per month for the period of September 1, 2024 to August 31, 2025.</p>

Revision to Policies & Procedures 30.100.1 – Second Reading	<p>Information: In 2020, Assembly Bill 1353 passed resulting in the shortening of the maximum probationary period for classified school district employees from the current maximum period (not exceeding one year) to a period not exceeding six months, or 130 days of paid service, whichever is longer. The change presented is intended to mirror this change. Text slated for addition in bold and italics; text slated for removal in strikethrough.</p>

<p>Motion: Second:</p>	<p>30.100.1 <u>Duration of Probation</u></p> <p>A new employee shall serve a probationary period of <i>six (6) months, or 130 days of paid service, whichever is longer</i>, one (1) year in one class before attaining permanency. Afterschool-Head Start Subscriber Fee Schedule</p> <p>Attachment 12</p> <p>Motion: Second:</p>	<p>Information: A Non-Public Agency (NPA) has recently reached out to inquire about possibly joining our services. An NPA is essentially a staffing agency for certain hard to fill positions for school districts. At the current time there is not a mechanism for them to join our services.</p> <p>RECOMMENDATION: Adjust the Afterschool-Head Start Subscriber fee schedule and allow for Non-Public Agencies to be included with this group, much like we recently added Non-Public Schools to be included along with Charter Schools.</p>

<p>13. Formal Position on AB1699</p> <p>Motion: Second:</p>	<p>Information: Assembly Bill 1699 has been forwarded to the State Senate for committee review and potential approval. As you may be aware, AB1699, in part, seeks to dictate the process for the promotion of current employees. As currently drafted, it does this almost exclusively based on seniority and without any form of employment testing other than a review of the minimum qualifications.</p> <p>From CODESP's perspective, this bill is a credible threat to the well-being and financial stability of CODESP as an organization. If AB1699 passes, in its current form, it would lead to a sharp reduction in the amount of employment testing conducted within California educational agencies, including the elimination of nearly all testing for promotional opportunities. Employment testing materials are CODESP's flagship product, so a potentially sharp decline in current and new memberships could be anticipated.</p> <p>RECOMMENDATION: Approve a formal position of "Opposed" on AB1699 and direct the Executive Director to take appropriate action (contacting representatives, etc.) based on this position.</p>
