Topics include:

Employee Classification and NCLB Act Impact

Speaker: Paul Loya, Partner: Atkinson, Andelson, Loya, Rudd & Romo. Mr. Loya will provide participants with information regarding properly classifying short-term and substitute employees. He will also discuss the impact of the NCLB Act on selection and bargaining. Mr. Loya is the firm's senior partner in the Pleasanton office and he represents school and college districts as legal counsel and as a labor management negotiator. He has successfully litigated employee termination cases in Federal and State court and has handled appeals through the California and U.S. Supreme Courts. Mr. Loya represents school districts and community colleges in all matters including litigation, PERB proceedings, general school law matters, and teacher dismissal cases.

FMLA and School District Legal Updates

Speaker: Emi Uyehara, Partner: Liebert, Cassidy, and Whitmore. Ms. Uyehara will provide participants with a legal update on school district issues and the FMLA. For more than twenty years, Ms. Uyehara has been representing public sector clients on behalf of management in labor, employment, and student matters. CODESP's Executive Director Marianne Tonjes will answer questions regarding their test materials.

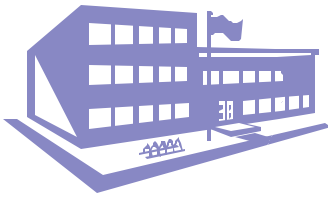
