Our item bank of multiple choice test questions contains over 21,000 test items. After submitting a CATS Request, your agency receives job-related test items for review and online test generation. New multiple choice test items will be developed if needed. Always attach a job description and any other helpful material such as item specific information and reference material from Subject Matter Experts (SMEs). After the materials are developed they will require SME review and feedback. Item analysis information can also be used to determine the effectiveness of the multiple choice test items at your agency. Custom test development services are included in our low yearly fee.
