INTERVIEW BUILDER

The interview builder is currently in beta testing with some of our customers. Our initial feedback has been very positive. This new software will be available on your CATS home page after login. Interview questions can be selected by Competency, Job Family and Job Level by using a “shopping cart”. Customers will also be able to add probes. Unlike other interview builders, CODESP’s allows for customization. The final interviews appear on a form with room for notes and a behavioral anchored rating guide. Every section of the final form can be edited by the customer. We know our customers have unique needs, and we design our products to be edited easily to fit those needs.

We hope to have the system available in June, and we will continue to add interview questions after the launch. Customers can add their own questions to the bank as well.



CUSTOMER SURVEY

New & Edited Items

Since March of this year CODESP has been diligently working on a major multiple choice item bank overhaul. Because of constantly changing technology, work demands, procedures, and testing strategies, we have been editing a large amount of our items as well as writing new items. There has been nearly 700 new or edited items since the beginning of March, and we hope to keep this pace as the year moves forward. Because of this we would like to stress the importance of keeping your tests up-to-date.

As we make edits to items, you will notice these changes in your “Create-A-Test” database. This area is a dynamic database linked to our central database. On the contrary, items will NOT change once they have been placed into a test in your Test Library. The tests will remain the same. Once you have created a test, the items in the test are no longer dynamically changing as they do in the “Create-A-Test” database. Thus if you just want to have the newest version of your current tests, you can always go back into “Create-A-Test” and recreate your tests using the most updated items.

The best practice is to submit new requests for materials rather than using old packets in your “Create-A-Test” database. Please feel free to contact us about the best ways to ensure your multiple choice items and tests are up-to-date.

Also, know that we always appreciate feedback on our items. We rely on our customer base to provide subject matter experts in the development and review of our items. Any new items that you submit or changes to items you request are welcomed. We do have to go through some procedural reviews of such items to be sure they are applicable to our wide customer base and written in CODESP’s uniform style, but we enjoy working with you to ensure you get the best testing materials possible.
